MINUTES OF JULY 1, 1929.

A regular meeting of the Council of the Town of San Anselmo was held on Monday, July 1st, 1929, at the hour of 8 o'clock P.M.

Present: Councilmen Smith, Hensley and Schmidt.
Absent: Councilmen Siemer and Fusselman.

The minutes of the previous meeting were read and approved.

Councilman Hensley was appointed Chairman of the Finance Committee, pro tem.

The Clerk having checked the signatures on the Hawthorn Hills petition with the great Register and finding approximately 100% in favor of annexation, the matter was referred to the Committee with instructions to prepare the Resolution calling for a special election. The Engineer

was directed to check same, as to property description. Upon motion of Councilman Hensley, the existing lights along San Anselmo Avenue were ordered moved to locations to be selected and approved by the Lighting Committee. Motion was seconded by Councilman Smith and carried by the following vote:

Absent: Councilmen Siemer and Fusselman.

Councilman Hensley reported that a new fire hydrant had been recently installed at the end of Redwood Road.

Councilman Hensley introduced the following Resolution and moved its adoption:

"RESOLVED that the Superintendent of Streets be and he is hereby authorized and directed to notify in writing the owners of the property fronting on Scenic Avenue between Elm and San Anselmo Avenues, where sidewalks are not now constructed, to immediately construct the same, subject to the approval of the Town Engineer; and further

RESOLVED that if such owners do not so construct such sidewalks within two weeks after receiving notice so to do by the Street Superintendent, that the Town Engineer be and he is hereby authorized and directed to prepare plans and specifications for the construction of such sidewalks."

Resolution was seconded by Councilman Smith and carried by the following vote:
