

A regular adjourned meeting of the San Anselmo City Council was held at the City Hall, San Anselmo on August 25th, 1953 at 8:00 P.M.

On motion of Councilman Skinner and seconded by Councilman Hannigan the reading of the minutes of August 11th be dispensed with.

On motion of Councilman Skinner tax rate of \$1.20 be approved, as follows

Councilman Hannigan seconds the above rate. Passed unanimously by Council.

Councilman Skinner moves council authorize Mrs. Grant to have floor plans drawn for ladies lounge and addition to office. The amount of \$50.00 limit for the plans. Councilman Hannigan seconds same. Passed unanimously.

Councilman Hannigan moves Chief Marcucci and Mr. Oglesby prepare plans for the repair of ditch at Recreation Park. Councilman Skinner seconds same. Passed unanimously by Council.

Councilman Skinner moves the auditing of the books for 1952-53 be given to George Franzman. Councilman Smith seconds same. Passed unanimously.

Mrs. E. Simmonds, 44 Mariposa Ave., letter regarding parking conditions on Marisposa Ave. Chief Wood to investigate this matter.

On motion of Councilman Smith and seconded by Councilman Wadlewski the week of September 7th to 13th be proclaimed "Union Label Week". Passed Unanim.

RESOLUTION #611 - prohibiting parking on Humboldt Ave. Councilman Smith moves resolution be accepted. Councilman Wadlewski seconds same. Passed Unanimously by Council.

RESOLUTION #612 - Authorizing one hour parking on both side of Belle Avenue for a distance of 250 feet Westerly from the Westerly line of San Anselmo Avnue. Councilman Smith moves this resolution be adopted. Councilman Hannigan seconds same. Passed unanimously by Council.

ORDINANCE #354 - An ordinance amending Ord. 207 entitled "An Ordinance regulating traffic upon the public streets of the Town of San Anselmo and repealing all ordinances inconsistent herewith" by adding a new section 31 (c) regulating parking on grades and amending article I defining streets, and amending section 30 (4) restricting parking near intersections. Councilman Smith moves above ordinance be accepted. Councilman Hannigan seconds same. Passed unanimously.

ORDINANCE #355 - An ordinance regulating physical structures from which the sale and vending of personal property may be made and conducted in the Town of San Anselmo. Councilman Skinker moves council dispense with reading in full. Councilman Hannigan seconds same. Councilman Hannigan moves Ord. #355 be adopted. Councilman Wadlewski seconds same. Passed unanimously.

RESOLUTION #609 - A resolution amending Rule V, Section 8, Rule XII, section 3, Rule XII of Resolution No. 128 entitled " A Resolution of the city Council of the Town of San Anselmo, Marin County, California, approving and adopting rules and regulations for the Administration of the Civil Service System of said Town." Councilman Hannigan moves resolution be accepted. Councilman Smith seconds same. Passed unanimously.

RESOLUTION #610 - A resolution amending Rule XXII of Resolution #128 entitled "AResolution of the City Council of the Town of San Anselmo, Marin County, California, approving and adopting rules and regulations for the Administration of the Civil Service System of said Town. Councilman Smith moves resolution be accepted. Councilman Hannigan seconds same. Passed unanimously by Council.

Councilman Wadlewski moves Mr. Phillip Bundschu be appointed to the Civil Service Board of Review, filling the unexpired term of Mr.Wadlewski. Councilman Skinner seconds this appointment. Passed unanimously by Council.
