

ORDINANCE NO. 101

ESTABLISHING THE GRADE OF A PORTION OF SAN ANSELMO AVENUE BETWEEN MARIPOSA AVENUE AND ROSS AVENUE AND OF ROSS AVENUE BETWEEN SAN ANSELMO AVENUE AND JONES STREET.

The Board of Trustees of the Town of San Anselmo do
ordain as follows :

Section 1.- The official curb grade of San Anselme Avenue between Mariposa Avenue and Ross Avenue and of Ross Avenue between San Anselme Avenue and Jones Street, is hereby established in accordance with the following elevations:

At the intersection of Ross Avenue and San Anselme Avenue, the elevation of Sub-grade shall be 41.0 feet above the official base.

At the intersection of San Anselme Avenue and Mariposa Avenue the elevation of Sub-grade shall be 59.0 feet above the official base.

At the intersection of Ross Avenue and Jones Street the elevation of Sub-grade shall be 42.4 feet above the official base.

True grade lines shall connect the intersections above named.

Section 2.- This Ordinance shall take effect and be in force sixty (60) days from and after the date of its passage and approval.


