

AMENDING ORDINANCE NO. 100. ESTABLISHING FIRE LIMITS.

The Board of Trustees of the Town of San Anselmo do ordain as follows:

Section 1.- Ordinance No. 100 is hereby amended to read as follows:-

That portion of the Town of San Anselmo within the boundary lines in this ordinance hereinafter set forth shall be known as the Fire Limits.

Commencing at the extreme Southwesterly corner of the property of Caroline L. Oegood, running thence Northeasterly One Hundred and twenty five (185) feet; thence Northerly and parallel with the Westerly line of the property of the said Caroline L. Oegood to the Northerly line of the property of said Caroline L. Oegood; thence Southwesterly along said Northerly line of said property of said Caroline L. Oegood; thence Southwesterly along said Northerly line of said Northerly line of said Caroline L. Oegood, to a point where said Northerly line of said Caroline L. Tract; thence Northerly and along the Westerly line of said Lot Seventeen (17) to the Northwesterly corner of said Lot Seventeen (17) thence Northerly across Tunstead Avenue to the Southwesterly corner of Lot Seven (7) of the Linda Vista Tract; thence Northerly along the Westerly line of said Lot Seven (7) to the Northwesterly corner of said Lot seven (7); thence Easterly along the Southerly line of Laurel Lane to a point One Hundred and Twenty-five feet west of the Westerly line of San Anselmo Avenue; thence Northerly in a straight. line to a point on the Southerly line of Magnolia Avenue, which point is one hundred and twenty-five (125) feet west of the westerly line of San Anselmo Avenue; thence Northerly in a straight line to the Southwest corner of Lot Two (2), of Ross Valley Park, as per map of Subdivision One (1) thereof; thence Northerly along the Westerly line of said Lot Two (2) to the Northwesterly corner of said Lot Two (2) and the Southerly line of Tamalpais Avenue; thence Easterly along the Southerly line of Tamalpias Avenue to the Northeasterly corner of Lot One (1) of said Ross Valley Park, as per said Map; thence Northerly to the Southerly line of said Bridge opposite said Tamalpais Avenue; and thence Northeasterly in a straight line to the point of beginning.

Section 2.- All ordinances and parts of ordinances in conflict herewith are hereby expressly repealed.

Section 3. - This Ordinance shall take effect and be in force thirty (30) days from and after its passage.
