AN ORDINANCE TO BE KNOWN AS THE ELECTRICAL CODE OF THE TOWN OF SAN ANSELMO, CREATING THE OFFICE OF CHIEF ELECTRICAL INSPECTOR, PRESCRIBING HIS DUTIES, PROVIDING FOR THE ISSUANCE OF ELECTRICAL PERMITS AND FOR INSPECTIONS AND FIXING THE FEES THEREFOR; REGULATING THE INSTALLATION, ARRANGEMENT, ALTERATION, REPAIR, MAINTENANCE AND OPERATION OF ELECTRIC WIRING, ELECTRIC FIXTURES, AND OTHER ELECTRICAL APPLIANCES AND EQUIPMENT IN THE TOWN OF SAN ANSELMO; PROVIDING A PENALTY FOR THE VIOLATION OF THE SAME AND ADOPTING THE UNIFORM ELECTRICAL CODE PUBLISHED BY THE PACIFIC COAST ELECTRICAL BUREAU BY REFERENCE; AUTHORIZING THE CHIEF ELECTRICAL INSPECTOR TO ADOPT AND ENFORCE INTERIM REVISIONS TO THE 1940 EDITION OF THE NATIONAL ELECTRICAL CODE DURING THE NATIONAL EMERGENCY BY AMENDING SUB-SECTION D, SECTION 8, AND REPEALING ALL ORDINANCES IN CONFLICT HEREWITH.

The City Council of the Town of San Anselmo, California, do hereby ordain as follows:

SECTION 1: CHIEF ELECTRICAL INSPECTOR: CREATION. There is hereby created and established the office of CHIEF ELECTRICAL INSPECTOR for the Town of San Anselmo, California, whose authority and duties shall be as set forth and contained in the Uniform Electrical Code hereinafter adopted by reference.

SECTION 2: All that certain "Uniform Electrical Code" so entitled, published by the Pacific Coast Electrical Bureau, 1941 Edition, three copies of which, in printed book form, have been filed and are now on file in the office of the City Clerk of said Town marked "filed" therein on the 7th day of December, 1943, for use and examination by the public, is hereby adopted as the Uniform Electrical Code of and for the Town of San Anselmo, California, to which reference is hereby made with like effect as if all of the provisions and printed matter therein were herein set forth in full, excepting, however, that the words "a competent electrician" appearing in lines 3 and 4 of Section 1 of said Code, shall be and they are hereby deleted from said Code and the Chief Electrical Inspector therein and herein provided need not be a competent electrician; and further excepting, however, that the provisions contained in Section 1 of said Code requiring the Chief Electrical Inspector to file a bond in the sum of One Thousand Dollars (\$1,000.00) before entering upon the discharge of his duties, shall be and they are hereby deleted and the Chief Electrical Inspector therein and herein provided, need not be required to file any bond before entering upon the discharge of his duties.

SECTION 3: Except as hereinabove excepted all of the pages, titles, printed matter, indexes, parts, chapters, paragraphs, sections, subsections, subdivisions, provisions, regulations and penalties therein provided and contained are hereby adopted as the rules and regulations for the government and regulation of the installation, arrangement, alteration, repair, maintenance and operation of the electrical wiring, electric fixtures and other electric appliances and equipment in said town.

SECTION 4: The penalties for violation of any of the provisions of this Ordinance or of said Uniform Electrical Code shall be as expressed and provided in said Code and in lieu of the City Jail mentioned in Section 23 of said Code the County Jail of the County of Marin is hereby fixed as the place of imprisonment for violation of said Code.

SECTION 5: Each of the matters and things in said Code declared to be unlawful or in violation thereof is hereby declared to be unlawful and in violation of said Code.

SECTION 6: All ordinances and parts of ordinances in conflict herewith are hereby repealed.

SECTION 7: Subsection D, Section 8 of said Uniform Electrical Code shall be and is hereby amended to authorize the Chief Electrical Inspector to adopt and enforce such interim revisions to the 1940 edition of the National Electrical Code as may be adopted during the present war emergency.

SECTION 8: This ordinance shall be published once in full in the San Anselmo Herald, a weekly newspaper, printed, published and circulated in said Town and shall be in full force and effect from and after its final passage.

The above and foregoing Ordinance No. 278 ^{30 DAYS} was ~~read~~ ^{duly & regularly} and introduced at a regular meeting of the City Council of the Town of San Anselmo held on 9th the 9th day of November, 1943, and was thereafter adopted at a ^{adjourned} regular meeting of said council held upon the 7th day of December, 1943, by the following vote, to-wit:
