12 be the Wade Thomas School, 115 Kensington Road

13 CONSOLIDATED VOTING PRECINCT "B", comprising State and County
14 Precincts 218, 219, and 232, and the polling place thereof shall
15 be at the City Hall, San Anselmo Avenue.

16 CONSOLIDATED VOTING PRECINCT "C" comprising State and County
17 Precincts Nos. 215 and 233 and the polling place thereof shall be
18 Myers Roofing Service and Supply Co., Redhill Ave.

19 CONSOLIDATED VOTING PRECINCT "D" comprising State and County
20 Precincts Nos. 214, 216, 226, and 234, and the polling place thereof
21 shall be the Isabel Cook School, Sir Francis Drake Blvd.

22 CONSOLIDATED VOTING PRECINCT "E" comprising State and County
23 Precincts Nos. 220, 223, 224, 227, 228, and 238, and the polling
24 place thereof shall be the Yolandsdale School located on San Anselmo
25 Ave. and Elm Ave.

26 CONSOLIDATED VOTING PRECINCT "F" comprising State and County
27 Precincts Nos. 221, 222, 225, 229, 235, 236, 237, and the polling place
28 thereof shall be the Brookside School at Brookmead Court.
