

1 WHEREAS, heretofore on the 20th day of June 1950, William
2 B. McGough and Gene C. Nolin filed a verified petition, pursuant
3 to Ordinance # 254, for the rezoning of all that certain real prop-
4 erty situate in the Twon of San Anselmo, County of Marin, State
5 of California, described as follows, to-wit:

6 Lots 1 to 5 inclusive, Block A, Carrigan Tract
7 from First Residential District Property to Second Residential
8 District property, as said districts are delineated and shown
9 in Ordinance #254 of the Twon of San Anselmo, and

10 WHEREAS, said City Planning Commission has considered said
11 verified petition, and said Planning Commission has made its
12 Tentative Report thereof, and

13 WHEREAS, the City Council of the Twon of San Anselmo and
14 the City Planning Commission of the Town of San Anselmo there-
15 after fixed the 24 day of July 1950 and the 31st day, of July 1950
16 as dates for public hearings on said tentative report, and

17 WHEREAS, the Planning Commission gave due notice of said
18 meetings as required by law and the order of the City Council,
19 and held said public hearings at the times and places specified,
20 affording all interested persons an opportunity to be heard, and

21 WHEREAS, on the 8 day of August 1950, the City Planning
22 Commission filed its final report with the City Council of the
23 Town of San Anselmo, and

24 WHEREAS, the City Council of the Town of San Anselmo, on
25 the 8th day of August 1950 received said final report, and it
26 appearing that the City Council should hold a public hearing on
27 said final report and said verified petition as required by law,

28 NOW, THEREFORE, BE IT RESOLVED by the City Council of the Town
29 of San Anselmo as follows:

- 30 1. That the 29th day of August 1950, at the Council Cham-
31 bers, in the City Hall in the Town of San Anselmo, County of

(b) Publication of a copy of the attached notice in the Independent-Journal, a newspaper of general circulation in the Town of San Anselmo in at least three separate issues within one week preceding the date of said hearing.

9 No. 254 of the Town of San Anselmo, and


10 WHEREAS, the Planning Commission heretofore made its tentative
