1. Dimensioned and scaled drawing of each proposed sign (includes any moving part, lighting, sound equipment, framework, background material, structural support, or other part); and
2. Dimensioned and scaled building and/or fence elevation(s) showing existing and proposed sign locations on those elevations; and
3. Color Samples.

Additional information may be requested should it be determined to be necessary to properly evaluate the application, including: materials, site plan in color (showing the location of property lines, buildings, parking areas, driveways, landscaped areas, utility poles and wires), and photographs of the property and building on which the sign is proposed to be erected or displayed.
