SUBJECT: Appointments

RECOMMENDATION

That Council review the list of Town Council committee assignments and make changes or new appointments as needed to fill current vacancies.

BACKGROUND

Town Councilmembers serve on a variety of committees, some of which are internal to the Town and some of which are regional. With the recent election of two new Councilmembers, it has been the Council's practice to review the list of appointments and make new appointments as desired.

DISCUSSION

The following is a list of the current assignments:

- **Association of Bay Area Governments (ABAG) General Assembly** – The ABAG General Assembly meets twice a year in Oakland. (Coleman; alternate Vacant)
- **Bolinas Avenue Advisory Committee** – One seat. This committee meets as needed to address infrastructure issues on Bolinas Avenue. (Vacant)
- **Capital Program Monitoring Committee** – Two seats. This committee meets once or twice a year in the evening to review the Public Works Director's recommendations for capital improvement projects, including paving and drainage, in the upcoming year and makes a recommendation to the full Council. This Committee may change its charge to include Measure D Oversight. There are currently six citizen members. (McInerney and Vacant)
- **CDBG Upper Ross Valley** – One seat. This group is made up of representatives of the upper Ross Valley and they decide Community Development Block Grant funding for local projects. The group meets 1 or 2 times a year in the evening. (Coleman)
- **Central Marin Police Authority Council** – Two seats. The CMPA Council is responsible for the administration and oversight of the Central Marin Police Authority and it meets quarterly in the evening. (Greene and McInerney, alternate Coleman)
- **Chamber of Commerce liaison** – One seat. This person is the Town Council liaison to the Chamber and attends their monthly meetings (usually on the third Tuesday morning), and

keeps the manager and other Councilmembers informed of what's happening with the Chamber. (Vacant)

- **Downtown SA Merchants liaison** – Two seats. These representatives serve as the Councilmember contact to the downtown merchants, keeps the manager and other Councilmembers informed of what's happening. (Coleman and Vacant)
- **Economic Development Committee** – Two seats. These persons work with the Economic Development Committee, 7 members of the public, to encourage the economic development of San Anselmo. Meets monthly on the first Tuesday at 8:45 a.m. (Coleman and Vacant)
- **Flood Committee** – 2 seats. This committee consists of two Councilmembers and five members of the public with engineering or technical expertise. They work with the Ross Valley Watershed group and its technical committee to ensure that flooding issues in San Anselmo are addressed. Meets quarterly, more often if needed (evening meeting). (Greene and McInerney)
- **Flood Control District Zone 9 Advisory Board** – One seat. The Flood Control District's governing body is the County Board of Supervisors. This group is an advisory body representing Larkspur, Ross, Fairfax, San Anselmo, the County and several members at large. Meets in the evening approximately 4 times per year. (McInerney)
- **Homeless Policy Steering Committee** – One seat. Represents San Anselmo in the County group dedicated to reducing issues around homelessness. (Coleman)
- **League of California Cities, North Bay** – One seat. This person serves as the Town's representative to the North Bay Division of the League of California Cities. They meet quarterly around the North Bay for dinner meetings to share information. (Coleman)
- **Lombard Property** – Two seats. This committee has not met but was originally convened to work with neighbors on the possible sale of property off Oak Spring to repay a \$500K loan to the Town's insurance authority. (Greene and Vacant)
- **Marin Energy Authority** – One seat: This JPA works to purchase green energy for Marin member cities, and meets once a month on the first Thursday, 7 p.m. (Greene, alternate McInerney)
- **Marin Telecommunications JPA** – One seat. This is the Joint Powers Authority that oversees the Comcast franchise and works on other telecommunication issues. It meets bi-monthly on the second Wednesday. (Coleman, alternate Greene)
- **MCCMC JPA Oversight Committee** – One seat. MCCMC is the Marin County Council of Mayors and Councilmembers, a group that meets monthly for dinner and a meeting to share ideas and reports. The JPA oversight committee was set up to ensure that all the various JPA's on which Marin cities/towns collaborate are well run and serving their purpose. (Vacant, alternate Coleman)

- **Marin Emergency Radio Authority (MERA)** – One seat. This group is responsible for oversight of the operation of the MERA radio system. (Coleman, 1st alternate Stutsman, 2nd alternate Vacant)
- **MCCMC Legislative Committee** – One seat. This group meets monthly to discuss pending federal and state legislation affecting cities and to make recommendation to MCCMC members on action to be taken. Meets on the fourth Monday of each month at 8 a.m. in San Rafael City Hall. (Greene, alternate McInerney)
- **Ross Valley Fire Board** – Two seats. The Fire Board meets once a month on the second Wednesday at 6:30 p.m., at the downtown SA fire station. Fairfax, Ross and Sleepy Hollow also have two seats. (McInerney, Vacant; alternate Coleman)
- **Ross Valley School District** – One seat. Serves as the liaison between the school district and Town. (Vacant, alternate Coleman)
- **Safe Routes to School** – One seat. Serves as the Town representative to Safe Routes. (Vacant, alternate Vacant)
- **Transportation Authority of Marin (TAM)** – One seat. TAM was established between the County and cities of Marin to address Marin's transportation needs, funded by a sales tax measure. The Board meets the fourth Thursday of each month at 7:30 p.m. (Greene, Alternate: McInerney)
