MINUTES OF FEBRUARY 21st, 1921

A Regular Adjourned meeting of the Board of Trustees was held on Monday evening February 21st, 1921 at 8 o'clock P. M.

The minutes of the meeting of February 7th, 1921 were read and approved.

YOLANDA COURT JOB

This being time set for hearing of protests on the work contemplated to be done under Resolution of Intention No. 31 for the improvement of roads in Yolanda Court and no protests having been received by the Clerk up to this time, Trustee Thomas introduced a Resolution Ordering the work proposed to be done under said Resolution of Intention No. 31 and moved it s adoption. The motion to adopt said Resolution was seconded by Trustee Hund and carried by the following vote:-

Ayes, Trustees Hund, Linnell, Stephenson, Thomas and Pinkham. Noes, None Absent, None.

Trustee Thomas thereupon introduced a Resolution directing that the above proposed work to be done under Resolution of Intention No. 31 be done under the supervision of the Town Engineer instead of the Superintendent of Streets and moved its adoption. The motion to adopt said Resolution was seconded by Trustee Linnell and carried by the following vote:

IMPROVEMENT AT ENTRANCE TO FLORIBEL PARK

A petition was received and read signed by property owners in the neighborhood of the entrance to Floribel Park, requesting the

Board to take some action towards having the roads improved and storm waters taken care of. The Clerk was directed to notify each of the signers of the petition that the members of the Board and the Town Engineer would meet with them on Wednesday evening, March 2nd, 1921 at 8 o'clock P. M. at the Town Hall and discuss the matter.

IMPROVEMENT/OF SAN FRANCISCO BOULEVARD

A petition signed by residents in the Short Ranch Tract in the vicinity of San Francisco Boulevard requesting the Board to make some improvements on said road was read by the Clerk and referred to the Street Committee.

PROTEST TO OAK PARK IMPROVEMENT

A protest signed by residents of Oak Park, against any improvement to be made in Oak Park that would be assessable against the property was read by the Clerk and ordered filed as the Board was not contemplating any improvement in that section.

SEQUOIA PARK IMPROVEMENT

A request from the Doherty Company to include Ancha Vista Avenue in the work contemplated to be done in Sequoia Park was upon motion of Trustee Thomas, seconded by Trustee Linnell granted, and the Engineer instructed to include that street in the plans now being prepared.

COMMUNICATIONS

A letter from the Pacific Gas and Electric Company requesting the Board to help them in stopping small boys from breaking the lights and sockets used in street lighting was read and referred to the Marshal.

A letter from Mr. H. Plath stating that he would be unable to appear at the meeting but that he was heartily in favor of any improvement to be made in Floribel Park was read and ordered filed.

A report from Marshal J.W.Mellor that on several instances he had been compelled to call attention of the Bank employees to carelessness in leaving windows open was read and ordered filed.

CHANGE OF GRADES -- INSIDE ROADS (Resolution of Intention No. 32)

Trustee Linnell introduced a Resolution of Intention to change the grades of certain streets contemplated to be improved under the \$95,000. Bond issue recently voted by this Town and commonly known as the inside roads, and moved its adoption. The motion to adopt said resolution was seconded by Trustee Thomas and carried by the following vote

Said Resolution of Intention was numbered 32.

IMPROVEMENT OF WOODLAND AVENUE

Upon motion of Trustee Thomas, seconded by Trustee Hund, the Clerk was directed to send notices to abutting owners along the so-called Worn Lane or Woodland Avenue and to owners in the neighborhood of the western terminus of said street to appear before the Board and the Town Engineer on Wednesday evening March 9th, 1921 and discuss the matter of improving said road.

IMPROVEMENT OF REDWOOD ROAD

This being the time set for property owners to appear and discuss the matter of improvement of Redwood Wood between Yolanda Station and Oak Park and several being present in response to the notices sent out, the matter was talked over and laid over until the next meeting, the Engineer being instructed to look over the drainage questions involved in the meantime.

RENTAL OF CORPORATION YARD

Upon motion of Trustee Thomas, seconded by Trustee Hund, the Board was authorized to rent a portion of the corporation yard on Ross Avenue to Mr. Richard Leach at the rental of \$10.00 per month.

DRAINAGE PIPE

Upon motion of Trustee Linnell, seconded by Trustee Stephenson, the Clerk was directed to order thirty (30) feet of fifteen (15) inch corrugated iron culvert pipe.

DEMANDS

Upon motion of Trustee Huhd, seconded by Trustee Thomas, demands No. 215 to 220 inclusive as appear upon the demand and warrant register under this date were ordered paid.
