MINUTES OF APRIL 18, 1932.

An adjourned meeting of the Council of the Town of San Anselmo was held on Monday, April 18th, 1932, at the hour of 8 o'clock P.M.

The minutes of the meeting of April 15, 1932 were read and approved.

CANVASS OF MUNICIPAL ELECTION:

The Board thereupon proceeded to canvass the returns of the General Municipal Election held on April 11, 1932 and having ascertained the result of the vote cast, Councilman Jordan introduced the following Resolution and moved its adoption:

"WHEREAS, a General Municipal Election was held and conducted in the Town of San Anselmo on Monday, the 11th day of April, 1932, as required by law, and

WHEREAS, it appears that notice of said election was held and legally given, that voting precincts were properly established, that election officers were appointed, and election supplies were furnished, and that in all respects said election was held and conducted and the votes cast thereat received and canvassed, and the returns thereof made and declared in the time, form and manner as required by the general laws of the State governing elections in cities of the fifth and sixth class; and

WHEREAS, the Council of said Town met at the Council Chambers on Monday, the 18th day of April, 1932, to canvass the returns of said election and install the newly elected officers, as a result of which the Council finds that the number of votes cast, the names of the persons voted for, and other matters required by law to be as hereinafter stated;

NOW, THEREFORE, BE IT RESOLVED as follows:

That said regular Municipal Election was held and conducted in the Town of San Anselmo on Monday, the 11th day of April, 1932, in the time, form and manner as required by law; that there were three voting precincts established for the purpose of holding said election, consisting of a consolidation of the regular election precincts established for holding general State and County elections, as follows:

Consolidated Voting Precinct "A", comprising State and County Precincts Nos. 1, 2, 3 and 4.

Consolidated Voting Precinct "B", comprising State and County Precincts Nos. 5, 6 and 7.

Consolidated Voting Precinct "C", comprising State and County Precincts Nos. 8, 9, 10 and 11.

That the whole number of votes cast in said Town was 1447; that the names of the persons voted for, the offices for which said persons, together with the whole number of votes which they received in the entire. Town are as follows:

RESOLVED FURTHER, that at said General Municipal Election Wm. D. Fusselman, and R. H. Scotford were elected to the office of Trustee or Councilman of the Town of San Anselmo for the full term of four years; also that F. D. Burrows was elected to the office of Clerk and Assessor of said Town for the full term of four years; also that L. B. Crane was elected to the office of Treasurer of said Town for the full term of four years.

The Clerk shall enter on the records of the Council a statement of the result of the election, showing (1) the whole number of votes cast in said Town (2) the names of the persons voted for (3) the office which each person was voted for (4) number of votes given in each precinct to each of said persons (5) the number of votes given in said Town to each of said persons.

The Clerk shall immediately make and deliver to each of the persons elected a Certificate of Election signed by him and duly authenticated; he shall also impose the constitutional Oath of Office and have them subscribe thereto, whereupon they shall be inducted into the respective offices to which they have been elected."

Motion to adopt said Resolution was seconded by Councilman Wright and carried by the following vote:

Ayes: Councilmen McKannay, Siemer, Jordan, Wright and Fusselman. Noes: None.

Thereupon the Clerk's Oath was administered by Councilman Fusselman after which the Clerk administered the constitutional Oath to Wm. D. Fusselman and R. H. Scotford who took their seats as members of the Council.

The Oath of Office was also administered to L. B. Crane, Treasurer.

The Clerk sitting as Chairman Pro Tem announced that nominations for the office of President or Chairman of the City Council were in order; thereupon, Councilman Fusselman moved that the name of Wm. F. McKannay be placed in nomination for such office; no second to the motion. Councilman Jordan moved that the name of Wm. D. Fusselman be placed in nomination for such office. Councilman Wright seconded the motion and moved that nominations be closed. Thereafter a vote was taken for Wm. D. Fusselman as Chairman or President of the City Council of the Town of San Anselmo with a unanimous result. Councilman Fusselman was then declared elected, took the chair and proceeded with the regular business of the Council. The Chairman then appointed Councilman Scotford Chairman of the Police and Fire Committee and Councilman Wright was appointed Chairman of the Parks and Housing Committee.

The Ordinance was then signed by Mayor Fusselman and numbered

was read and referred to the Street and Parks and Housing Committees with power to act.

The communication from the Pacific Gas & Electric Co. relative to the illumination of two entrance signs (Bridge Street and Tunstead Ave.) was read and the Clerk was instructed to ascertain from the Company the approximate cost to the Town for such installation.

councilman Jordan reported that approximately 100 feet of fencing will be required in the Bridge area, abutting the Railroad right of way. He also reported that no action could be taken by the Council in regard to topping of trees in the vicinity of Mr. Carroll's property on Grove Lane for the reason that such trees are on private property.

The Superintendent of Streets was directed to confer with Mr. Minto concerning the driveway into his property leading into the "Ice Cream Freezer" on San Anselmo Ave.

There being no further business, the meeting was adjourned to Tuesday. May 10th, 1932, at the hour of 8 o'clock P.M.
