## MINUTES OF MEETING OF APRIL 27TH, 1938.

An adjourned regular meeting of the Council was held on Wednesday April 27, 1938, at 8 o'clock P.M.

The reading of the minutes of the previous meeting was dispensed with. The Clerk administered the Oath of Office to Councilman Millard who was not present at last meeting.

The petition of F. J. Main and other residents of Hawthorn Hills, for the improvement of streets throughout the tract, was referred to the Street Committee for recommendation.

A petition signed by D. Capurro, 23 Belle Ave., and other residents in the vicinity, for the abatement of a reported nuisance being maintained at the place of business of Mr. Muesdorfer, #27 Mariposa Ave., was read, and upon motion of Councilman Linch, seconded by Councilman White, and unanimously passing, a committee of three, Councilman Carroll, the Chief of Police and the City Attorney, was appointed to view the premises in their investigation and report back to the Council at next meeting.

On motion of councilman Millard, seconded by Councilman Carroll, and unanimously passing, Mr. Nipper's request for permission to remove a tree in back of his home was granted.

The communication of A. J. Raisch, relative to delinquencies in street bond payments was referred to the Attorney for consideration.

On motion of Councilman Carroll, seconded by Councilman White, and unanimously passing, the taxes levied against Lot 11, as per Map of Brookside Meadow, were ordered cancelled.

The reports of the Plumbing and Building Inspectors for the month of March were received and placed on file.

After some discussion on the matter of re-zoning certain lots in khz "Yolanda Park", the matter was referred to the City Planning Commission for recommendation.

Action on the weed clearing program for the coming year was deferred until the next meeting of the Council.

On motion of councilman Millard, seconded by Councilman Carroll, and unanimously passing, authorization to bring the Block Books up to date at an expenditure of approximately \$50.00 was given.

On motion of Councilman Millard, seconded by Councilman Linch, the use of the tennis courts on Sunday, May 14th, 1937, was reserved for the Hartford Insurance Company.

The claim of the Marin Oil & Burner Company vs. the Town of San Anselmo was referred to the Attorney.

The Mayor was reminded to be on the job to pitch the first ball on the opening date of base ball season.

Some discussion was had on the matter of a proposed W.P.A. Project, for the repairs to approximately  $3\frac{1}{2}$  miles of unimproved streets in Town, and upon motion of Councilman Carroll, seconded by Councilman Linch, and unanimously passing, the Superintendent of Streets was authorized to negotiate for the rental of a 50 h.p. "Bull Dozer"/operator for a period of ten days.
