Hub intersection design presented and discussed by council. City Administrator to talk to business people in this area and report back to council.

Transfer Funds - Cars amounting to \$2,355.77 - Change order No 2 \$663.00 Councilman Rouse moves approval to change ever No 2. Councilman Reichmuth seconds same. Passed unanimously Councilman Reichmuth moves approval of transfer of funds. Councilman Rouse seconds same. Passed unanimously

Statement in the amount of \$2928.62 payment to Oglesby, Jacobs & Wickham - final payment. Councilman Rouse moves to transfer from undistributed reserve to Councilman Reichmuth seconds same.

Report on furnishing new Fire Station. Councilman Little moves council authorize City Administrator to purchase items as recommended. Councilman Reichmuth seconds same. Passed unanimously

City Administrator reported on manpower for new fire house - reported 4 qualified on promotional examination - letter from Fire Chief recommending R. McLaren and W. Sousa as captains and W. Rawlins & R. Beedle as Lieutenants.

Councilman Little moves approval to the appointment of R. McLaren and W. Rawlins as captains, no appointment for Lieutenant at present. Councilman Franchini seconds same. Motion passed on following vote:

Councilman Rouse moves to authorize appointment of two firemen from eligible list names to be recommended at next meetin g. Councilman Reichmuth seconds same.

Passed unanimously

Councilman Little moves authorization to call for formal bids for improvement of recreation building to be opened January 10th. Councilman Reichmuth seconds same. Passed unanimously

Councilman Reichmuth moves to purchase of police insigias \$190.00 from undistributed reserve. Councilman Little seconds same. Passed unanimously

City Administrator recommends postpone street light report until Wilsey & Ham have their report completed.

Councilman Little moves approval to purchase mimeograph machine. Councilman Reichmuth seconds same. Passed unanimously

Report on improvement of San Anselmo Avenue, no parking would be allowed if State repairs same. City Administrator to notify people who own property at that area of meeting to be held on Jan. 17th.

RESOLUTION (Claims and demands amounting to \$54,457.92. Councilman Rouse moves approval. Councilman Reichmuth seconds same. Passed unanimously

Councilman Little moves letter be sent to Board of Supervisors to cancel past taxes on property of M. Paskow, property purchased by city.
