

Ordinance # 9

Relating to Guns and Explosives

The Board of Trustees of the Town of San Anselmo do ordain as follows.

Section I It shall be and is hereby made unlawful for any person or persons within the corporate limits of the Town of San Anselmo to discharge any pistol, firearm, air gun, musket gun, or any instrument of any kind, character or description, which throws or projects bullets or missiles of any kind, to any distance by means of the elastic force of air, or any explosive substance; to make use, or have in his possession, any sling shot, or other instrument or device by which missiles of any kind or description are hurled or projected or in any manner use the same to the danger or annoyance of any person or injury to property, except in a regularly built properly constructed shooting gallery.

Section II Any person violating any provisions of this article shall be guilty of a misdemeanor and shall be punished by a fine not less than five dollars (\$5.00) nor more than fifty dollars (\$50.00); and if default be made in the payment of such fine imposed, or any part thereof, then he may be imprisoned one day for each two dollars of such fine remaining unpaid.

This ordinance shall take effect immediately.

ORDINANCE NO. 9

"RELATING TO GUNS AND EXPLOSIVES"

The Board of Trustees of the Town of San Anselmo do ordain
as follows:

SECTION I.
