

ORDINANCE NO. 29100

ESTABLISHING FIRE LIMITS.

The Board of Trustees of the Town of San Anselmo do ordain as follows:

Section 1. That portion of the Town of San Anselmo within the boundary lines in this Ordinance hereinafter set forth shall be known as the fire limits.

The fire limits shall be bounded as follows, to-wit: Commencing at the extreme Southwesterly corner of the property of Carolina L. Osgood, running thence Northeasterly One hundred and twenty-five (125) feet; thence Northerly and parallel with the Westerly line of the said property of said Carolina L. Osgood to the Northerly line of the property of said Carolina L. Osgood; thence Southwesterly along said Northerly line of said property of said Carolina L. Osgood to a point where said Northerly line of said property of said Carolina L. Osgood intersects the Westerly line of said property of said Carolina L. Osgood; thence Southerly and along said Westerly line of said property of said Carolina L. Osgood to the point of commencement.

Also

Commencing at a point where the Southeasterly line extended of the wagon bridge across San Anselmo Creek opposite Ross Valley Avenue intersects the Southwesterly line of the right of way of the Northwestern Pacific Railroad Company, running thence Southerly and along said Westerly line of said right of way to the Southeasterly corner of Lot Twenty-one (21) of the Linda Vista Tract; thence at a right angle Westerly to a point in the center line of Oak Street; thence Northerly along the center line of Oak Street to a point where the center line of Pine Street, extended, intersects the center line of Oak Street; thence Westerly along the center line of Pine Street, extended, to a point where the

Westerly line extended of Lot Seventeen (17) of the Linda Vista Tract intersects the center line of Pine Street; thence Northerly across Pine Street to the Southwest corner of Lot Seventeen (17) of the Linda Vista Tract; thence Northerly and along the Westerly line of said Lot Seventeen (17) to the Northwesterly corner of said Lot Seventeen (17); thence Northerly across Elm Street to the Southwesterly corner of Lot Seven (7) of the Linda Vista Tract; thence Northerly along the Westerly line of said Lot Seven (7) to the Northwesterly corner of said Lot Seven (7); thence Northerly across Laurel Lane to the Southeasterly corner of Lot Twenty-four (24) of the Magnolia Tract; thence Northerly and along the Easterly line of said Lot Twenty-four (24) to the Southerly line of Magnolia Avenue; thence Easterly along the said Southerly line of Magnolia Avenue, Two hundred (200) feet, more or less, to a point where the Easterly line of Lot Three (3), extended, of Ross Valley Park, as per Map of Subdivision One (1) thereof, intersects the said Southerly line of Magnolia Avenue; thence Northerly along the Easterly line of said Lot Three (3), extended, to the Southeasterly corner of said Lot Three (3); thence Northerly along said Easterly line of said Lot Three (3) to the Southerly line of Ross Valley Avenue; thence Easterly along said Southerly line of said Ross Valley Avenue to the Northeasterly corner of Lot One (1) of said Ross Valley Park, as per said Map; thence Northerly to the Southerly line of said bridge opposite said Ross Valley Avenue; and thence Northeasterly in a straight line to the point of commencement.

Section 2. All Ordinances, and parts of ordinances, in conflict herewith, are hereby expressly repealed.

Section 3. This Ordinance shall take effect and be in force from and after its passage.
