

AMENDING SECTION 9 OF ORDINANCE NO. 90  
REGULATING THE CONSTRUCTION, ERECTION,  
ENLARGEMENT, RAISING, ALTERATION, REPAIR  
REMOVAL, MAINTENANCE, USE AND HEIGHT OF  
BUILDINGS, REGULATING THE CHARACTER AND  
USE OF MATERIALS IN AND FOR BUILDINGS, AND  
REPEALING ALL ORDINANCES IN CONFLICT WITH  
THIS ORDINANCE.

The Board of Trustees of the Town of San  
Anselmo do rodain as follows:

Section 1.- Section 9, of Ordinance No. 90 is hereby  
amended to read as follows:

The applicant or applicants for such building permit shall pay to the building Inspector for expenses of inspection and examination of the building and plans and specifications the sum of \$1.00 if the estimated cost of said building, structure, alteration or improvement shall be \$100.00 or more and less than \$200.00; the sum of \$2.00 if the estimated cost is \$200.00 or more and less than \$300.00; the sum of \$3.00 if the estimated cost is \$300.00 or more and less than \$400.00; the sum of \$4.00 if the estimated cost is \$400.00 or more and less than \$500.00; the sum of \$5.00 if the estimated cost is \$500.00 or more and less than \$1,000.00; the sum of \$10.00 if the estimated cost is \$1,000.00 or more and less than \$2,000.00; the sum of \$15.00 if the estimated cost is \$2,000.00 or more and less than \$5,000.00; the sum of \$20.00 if the estimated cost is \$5,000.00 or more and less than \$10,000.00; the sum of \$30.00 if the estimated cost is \$10,000.00 or more and less than \$15,000.00; the sum of \$40.00 if the estimated cost is \$15,000.00 or more and less than \$20,000.00; the sum of \$50.00 if the estimated cost is \$20,000.00 or more and less than \$25,000.00; and the sum of \$5.00 additional for every \$5,000.00 or fraction in excess of \$25,000.00.

Section 2.- This ordinance shall take effect and be in force Thirty(30) days from and after its passage.
