ORDINANCE REPEALING THE LICENSE TAX IMPOSED ON ALL PERSONS TRANSACTING OR CARRYING ON BUSINESS AS PHYSICIANS OR SURGEONS, ALSO CONTRACTORS OR BUILDERS, AND MODIFYING THE LICENSE TAX IMPOSED ON THE EXPRESS BUSINESS.

The Board of Trustees of the Town of San Anselmo do ordain as follows:

Section 1. All ordinances or parts of ordinances imposing a license tax on persons, firms or corporations transacting or carrying on business in the Town of San Anselmo as physicians or surgeons, also contractors or builders, are hereby repealed.

Section 2. Every person, firm or corporation transacting or carrying on business in the Town of San Anselmo as Expressmen shall pay a license tax according to the following classification:

Those who use one vehicle only in conducting said business, Five Dollars per year, and those who use more than one vehicle in conducting said business Ten Dollars per year, payable annually in advance. All ordinances or parts of ordinances in conflict with this section are hereby repealed.
