

ORDINANCE NO. 227

AN ORDINANCE PROHIBITING DOGS IN PLACES WHERE MERCHANDISE OR FOODSTUFFS ARE SOLD OR EXPOSED FOR SALE, AND ON STREETS OR SIDEWALKS WHERE MERCHANDISE OR FOODSTUFFS ARE BEING LOADED OR UNLOADED, AND REGULATING THE KEEPING OF DANGEROUS OR VICIOUS DOGS.

The City Council of the Town of San Anselmo do ordain as follows:

Section 1. No person owning or having possession of any dog shall permit the same to enter or be in any store, shop, premises or other place in the Town of San Anselmo where any merchandise, meat, vegetables, groceries, or any foodstuffs, are kept or stored, or offered or exposed for sale, on the floor thereof or in or on ~~shelves~~ shelves, bins, boxes, *or* crates, *or on showcases,* ~~or other receptacles~~, which are less than two feet above such floor.

Section 2. No person owning or having possession of any dog shall permit the same to be upon any public street or sidewalk in the Town of San Anselmo within a distance of ten feet of any merchandise or foodstuffs which are being loaded or unloaded, or are upon such street or sidewalk for delivery to or from any store, shop, premises or place.

Section 3. The owner or person in charge of any such store, shop, premises or other place in the Town of San Anselmo, shall exclude all dogs therefrom, and from within such distance of ten feet from any merchandise or foodstuffs so being loaded or unloaded or so upon such street or sidewalk.

Section 4. Any dog found in any such store, shop, premises or other place, or within such prohibited distance


stated, shall be taken by the Chief of Police and disposed of by him in the same manner as other dogs taken into custody by him.

Section 5. No person owning or having the possession of any dangerous or vicious dog shall permit such dog to run at large or be upon any public street, alley, lane, place or ground in the Town of San Anselmo without being secured, held, or led by a leash, cord, chain or other means of restraint, and unless such dog be securely muzzled; and no person owning or having the possession of any dangerous or vicious dog shall keep such dog on any land owned or possessed by him unless such dog be securely tied or confined so as to prevent it from injuring any person who may be lawfully upon such premises.


Section 6. Any person violating any of the provisions of this Ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be punished by a fine not exceeding one hundred dollars or by imprisonment for a period not exceeding two months, or by both such fine and imprisonment.

Section 7. This Ordinance shall be published once in the Marin Herald a newspaper of general circulation, published and circulated in said Town of San Anselmo, and hereby designated for that purpose.
