AN ORDINANCE AMENDING ORDINANCE NO. 207 OF THE TOWN OF SAN ANSELMO, ENTITLED, "AN ORDINANCE REGULATING TRAFFIC UPON THE PUBLIC STREETS OF THE TOWN OF SAN ANSELMO AND REPEALING ALL ORDINANCES INCONSISTENT HEREWITH" BY THE ADDITION THERETO OF THREE NEW SECTIONS TO BE NUMBERED SECTIONS 32.4, 32.5 and 32.6

The City Council of the Town of San Anselmo does ordain as follows:

Section 1. Ordinance No. 207 of the Town of San Anselmo is hereby amended by the addition thereto of three new sections to be known and designated as Sections 32.4, 32.5 and 32.6 respectively, and which said new Sections shall read as follows, to-wit:

Section 32.4: There shall be established, by resolution of the City Council as hereinafter specified, in the "business district" of the Town of San Anselmo, as said district is defined and delineated in this Ordinance, "patient discharge parking zones" which said zones will be marked and indicated by painting of the curb immediately adjacent thereto for the full length thereof a white color, and such other markings and signs as may be ordered by resolution of the City Council.

Section 32.5: The City Council shall, by resolution, fix and determine the location of "patient discharge parking zones" and shall direct the Chief of Police to appropriately mark such zones, and to paint the curb immediately adjacent thereto, for the full length thereof, a white color. Any such "patient discharge parking zone" may be placed at or near the entrance of any office building or premises in the Town of San Anselmo wherein are located the offices of doctors or dentists.

Section 32.6: Between the hours of eight o'clock A. M. and six o'clock P. M. of each day, including Sundays and holidays, it shall be unlawful for any person or persons to park a vehicle continuously for a longer period than three minutes in any "patient discharge parking zone," contrary to any zone sign or curb color marking herein specified, and it shall be unlawful for any person in any event to enter or use such "patient discharge parking zone" save and except for the sole purpose of discharging or picking up a patient who is destined for, or who is returning from, a doctor's or dentist's office in the premises at or near said "patient discharge parking zone."

Section 2. Copies of this Ordinance shall be posted within fifteen days after its final passage and adoption in three (3) public places in the Town of San Anselmo, to-wit:

- (a) Bulletin Board, San Anselmo Public Library ,
- (b) Bulletin Board, San Anselmo Post Office,
- (c) Bulletin Board, San Anselmo City Hall,

which said places are designated for that purpose and shall be in full force and effect thirty days after its final passage and adoption.

The foregoing Ordinance was duly and regularly introduced at a regular meeting of the City Council of the Town of San Anselmo, held in said Town on the 8 day of February, 1949 , and was thereafter on the 15 day of February, 1949 at a regular meeting of the City Council of the Town of San Anselmo held in said Town duly passed and adopted by the following vote:
