AN ORDINANCE AMENDING ORDINANCE NO. 290 OF THE TOWN OF SAN ANSELMO ENTITLED: "AN ORDINANCE TO REGULATE THE RATES, RULES, PRACTICES AND OPERATIONS OF TAXICABS IN THE TOWN OF SAN ANSELMO PRESCRIBING TERMS AND CONDITIONS UNDER WHICH SUCH OPERATIONS MAY BE CONDUCTED, AND PROVIDING PENALTIES FOR THE VIOLATION OF THIS ORDINANCE", BY AMENDING SECTION 20 THEREOF.

The City Council of the Town of San Anselmo does ordain as follows:

Section 1. Section 20 of Ordinance No. 290 of the Town of San Anselmo entitled: "An ordinance to regulate the rates, rules, practices and operations of taxicabs in the Town of San Anselmo prescribing terms and conditions under which such operations may be conducted, and providing penalties for the violation of this ordinance", is amended to read, as follows:

"Section 20. INSURANCE COVERAGE. Every owner operating in the Town of San Anselmo shall file with the City Clerk and thereafter keep in full force and effect a policy of insurance or bond in such form as the City Clerk may deem proper and executed by surety or sureties approved by the City Clerk, insuring the public against any loss or damage that may result to any person or property from the operation of such vehicle or vehicles: provided, the minimum amount of recovery in such policy of insurance or bond specified shall not be less than the following sums:

For the injury of any one (1) person or the death of any one (1) person in any one (1) accident, \$15,000.00.

For the injury of two (2) or more persons or the death of two (2) or more persons in any one (1) accident, \$30,000.00.

For the Injury or destruction of property in any one (1) accident, \$10,000.00."

Section 2. Ordinance No. ³²⁰~~320~~ of the Town of San Anselmo and all other Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

Section 3. This ordinance shall be published once in full within fifteen days after final passage in the SAN ANSELMO TIMES, a weekly newspaper of general circulation, printed, published and circulated in said city and hereby designated for that purpose, and shall be in full force and effect thirty (30) days after its final passage and adoption.

The foregoing ordinance was duly and regularly introduced at a regular meeting of the City Council of the Town of San Anselmo held in said Town of the 14th day of December, 1954, and was thereafter at a regular meeting of said City Council held in said Town of San Anselmo on the 11th day of January, 1955, duly passed and adopted by the following vote:
