ORDINANCE NO. 391

AN ORDINANCE REPEALING ORDINANCES NUMBERS 275 AND 330 AND AMENDING SECTION 5 OF ORDINANCE NO. 253 OF THE TOWN OF SAN ANSELMO, ENTITLED: "AN ORDINANCE DEFINING GARBAGE, PROVIDING FOR AND REGULATING THE KEEPING, COLLECTING AND DISPOSAL THEREOF; MAKING IT UNLAWFUL TO SPILL OR DEPOSIT GARBAGE IN PUBLIC PLACES OR UPON THE STREETS AND ALLEYS; FIXING RATES FOR COLLECTION OF GARBAGE PROVIDING FOR THE LETTING OF A CONTRACT FOR THE COLLECTING OF GARBAGE; PROVIDING A PENALTY FOR THE VIOLATION OF ANY PROVISIONS OF THIS ORDINANCE, AND REPEALING ALL ORDINANCES IN CONFLICT HEREWITH"

THE CITY COUNCIL OF THE CITY OF SAN ANSELMO DOES ORDAIN AS FOLLOWS:

SECTION 2: Section 5 of Ordinance No. 253 referred to in the title hereof is hereby amended as follows: In each instance where the expression "sixty cents" appears in said Section 5, ~~as amended~~, the same shall be stricken out and in lieu thereof there shall be inserted the expression "One dollar and twenty five" cents"; in each instance where the expression "eighty-five cents" appears in said Section 5 the same shall be stricken out and in lieu thereof there shall be inserted the expression "One dollar and fifty" cents"; in each instance where the expression "one dollar and thirty-five cents" appears in said Section 5, the same shall be deleted and in lieu thereof there shall be inserted the expression "two dollars" *and twenty-five cents.*

SECTION 3: This Ordinance shall be published once within fifteen (15) days after its passage in the SAN ANSELMO TIMES, a weekly newspaper of general circulation published and circulated in the City of San Anselmo, which said newspaper is hereby designated for that purpose.

SECTION 4: It is hereby found and declared that this Ordinance is urgently required for the preservation of the public peace, health and safety of the people of San Anselmo and is an emergency Ordinance. The facts constituting such emergency are as follows: The City Council of the City of San Anselmo has heretofore entered into a contract for the collection of garbage with Victor Vallergera under the terms of which the City agreed to amend its Ordinance to be effective as of the 1st day of August, 1955. That the greatly increased cost of garbage collection have made it impossible to collect and dispose of garbage at present rates and in order to avert a breakdown of garbage disposal in the City of San Anselmo and to assure the same good continuous service it is necessary that this Ordinance be made effective as of August 1, 1955, so as to give full force and effect to the contract hereinbefore referred to.

SECTION 5: This Ordinance shall be in full force and effect from and after August 1, 1955.

The foregoing Ordinance was duly and regularly introduced ^{passed and adopted} at a regular meeting of the City Council of the City of San Anselmo, held in said City on the 12th day of July, 1955, and ~~was thereafter adopted at a _____ meeting of said City Council held in said City on the _____ day of _____, 1955,~~ by the following vote, to wit:
