ORDINANCE NO. 436

AN ORDINANCE REPEALING ORDINANCE NUMBER 291 AND AMENDING SECTION 5 OF ORDINANCE 253 OF THE TOWN OF SAN ANSELMO, ENTITLED: "AN ORDINANCE DEFINING GARBAGE, PROVIDING FOR AND REGULATING THE KEEPING, COLLECTING AND DISPOSAL THEREOF; MAKING IT UNLAWFUL TO SPILL OR DEPOSIT GARBAGE IN PUBLIC OR UPON THE STREETS AND ALLEYS; FIXING RATES FOR COLLECTION OF GARBAGE PROVIDING FOR THE LETTING OF A CONTRACT FOR THE COLLECTING OF GARBAGE; PROVIDING A PENALTY FOR THE VIOLATION OF ANY PROVISIONS OF THIS ORDINANCE, AND REPEALING ALL ORDINANCES IN CONFLICT HEREWITH", and DECLARING AN EMERGENCY

THE CITY COUNCIL OF THE CITY OF SAN ANSELMO DOES ORDAIN AS FOLLOWS:

SECTION 1: Ordinance number 391 of the ^{City} Town of San Anselmo is hereby entirely repealed.

SECTION 2: Section V of Ordinance No. 253 referred to in the title hereof is hereby amended as follows: In each instance where the expression "sixty cents" appears in said Section 5, ~~as amended~~, the same shall be stricken out and in lieu thereof there shall be inserted the expression "One dollar and fifty cents"; in each instance where the expression "eight-five cents" appears in said Section 5 the same shall be stricken out and in lieu thereof there shall be inserted the expression "One dollar and seventy-five cents"; in each instance where the expression "one dollar and thirty-five cents" appears in said Section 5, the same shall be deleted and in lieu thereof there shall be inserted the expression "two dollars and fifty cents".

SECTION 3: The last paragraph of section V of Ordinance No. 253 is hereby amended to read as follows:

For one single collection of garbage, no part of a regular service, the rates for collection shall be twenty-

five percent (25%) more than 1/2 of the monthly rate for one collection per week, according to the can or receptacle, the premises and the part of said town from which said collection is made, according to the following schedule, to-wit:

Flat area, 30 gal. receptacle, or less, \$1.25 per month,

Flat area, 30 to 60 gal. receptacle, \$1.50 per month;

Hill area, 30 gal. receptacle or less, \$1.50 per month;

Hill area, 30 to 60 gal. receptacle, \$2.25 per month.

In computing said rate any fraction of a cent shall be disregarded.

SECTION 4.: This Ordinance shall be published once within fifteen (15) days after its passage in the Ross Valley Times, a weekly newspaper of general circulation published and circulated in the City of San Anselmo, which said newspaper is hereby designated for that purpose.

SECTION 5: It is hereby found and declared that this Ordinance is urgently required for the preservation of the public peace, health and safety of the people of San Anselmo and is an emergency Ordinance. The facts constituting such emergency are as follows: That the greatly increased cost of garbage collection have made it impossible to collect and dispose of garbage at present rates and in order to avert a breakdown of garbage disposal in the City of San Anselmo and to assure the same good continuous service it is necessary that this Ordinance be made effective as of July 1, 1958, so as to give full force and effect to the existing garbage franchise.

SECTION 6: This Ordinance shall be in full force and effect from and after July 1, 1958.

The foregoing Ordinance was duly and regularly introduced, passed and adopted at a adjourned regular meeting of the City Council of the City of San Anselmo, held in said City on the 12th day of June, 1958 by the following vote, to wit:
