ORDINANCE NO. 462

AN ORDINANCE AMENDING ORDINANCE NO. 461, ENTITLED,

"AN ORDINANCE ANNEXING CERTAIN UNINHABITED TERRITORY TO THE CITY OF SAN ANSELMO, SAID TERRITORY BEING GENERALLY KNOWN AS THE "SORICH DAIRY", AND SAID ANNEXATION BEING GENERALLY KNOWN AS THE "SORICH DAIRY ANNEXATION" BEING AN AREA OF SIXTY-ONE AND 62/100THS ACRES, MORE OR LESS"

BY ADDING THERETO THE DESCRIPTION OF SAN FRANCISCO BOULEVARD FROM THE CITY LIMITS TO THE SORICH DAIRY.

WHEREAS, pursuant to the provisions of the Uninhabited Territory Act of 1939, (Government Code Section 35300, et seq.) proceedings were initiated by the City Council of the City of San Anselmo to annex the territory described in this Ordinance, and

WHEREAS, all provisions of the law have been fully complied with and said annexation may be consummated, the City Council of the City of San Anselmo does ordain as follows:

SECTION 1. Section 1 of Ordinance No. 461 is hereby amended by adding thereto the legal description of San Francisco Boulevard, from the City limits of the City of San Anselmo northeasterly to its terminus with the Sorich Dairy property, as follows:

"Together with that section of San Francisco Boulevard being a parcel of land within the County of Marin, State of California, described as follows:

BEGINNING at the intersection of the southeasterly line of San Francisco Boulevard with the northeasterly boundary line of the City of San Anselmo, said point being distant along said boulevard line, S.37°57'W. 715.4 feet from its intersection with the northeasterly line of Sacramento Avenue, and running thence N.37°57'E. 715.4 feet to the northeasterly line of Sacramento Avenue; thence along said line of Sacramento Avenue, N.52°03'W. 35.46 feet and N.82°36'W. 33.77 feet to its intersection with the northwesterly line of said San Francisco Boulevard extended; thence along said last mentioned line, so extended, S.37°57'W. 700.55 feet to the aforesaid boundary of the City of San Anselmo; thence along said boundary line, S.52°03'E. 60.0 feet to the Point of Beginning.

SECTION 2. This Ordinance shall be in full force and effect thirty (30) days from and after its final passage and adoption, and the annexation shall be fully effective from the date the Secretary of State files a certified copy of this Ordinance.

SECTION 3. The foregoing Ordinance shall, within fifteen (15) days of its final passage and adoption, be published once in the Ross Valley Times, a weekly newspaper of general circulation, published and circulated in the City of San Anselmo, and hereby designated for that purpose, and said Ordinance shall be in full force and effect thirty (30) days after its final passage and adoption.

The foregoing Ordinance was duly and regularly introduced at a <u>regular</u> meeting of the City Council of the City of San Anselmo, held in said City on the <u>19th</u> day of <u>April</u>, 1960, and was thereafter at the <u>regular</u> meeting of said City Council, held in said City on the <u>10th</u> day of <u>May</u>, 1960, duly passed and adopted by the following vote:
