SECTION 1. That an amendment to the Contract between the \_\_\_\_\_

Administration, California Public Employees' Retirement System is hereby author-  
ized, a copy of said amendment being attached hereto, marked "Exhibit A," and by  
such reference made a part hereof as though herein set out in full.

SECTION 2. The \_\_\_\_\_ Mayor \_\_\_\_\_

AMENDMENT TO CONTRACT BETWEEN THE  
BOARD OF ADMINISTRATION  
PUBLIC EMPLOYEES' RETIREMENT SYSTEM  
AND THE  
CITY COUNCIL OF THE  
CITY OF SAN ANSELMO

The Board of Administration, Public Employees' Retirement System, hereinafter referred to as Board, and the CITY COUNCIL of the CITY OF SAN ANSELMO, hereinafter referred to as Public Agency, having entered into a contract under date of April 24, 1959, effective July 1, 1959, and as amended effective January 1, 1964, and November 1, 1966, which provides for the participation of Public Agency in said System, Board and Public Agency hereby agree as follows:

A. The following sub-paragraph shall be added to said Contract:

10 (f) Section 21251.75 of the Government Code (providing for increases in allowances payable for time commencing on the first day of the calendar month coinciding with or next following the effective date of this amendment to persons retired prior to January 1, 1967).

B. Paragraph 11 (a), and 11 (b), shall be stricken from said contract and the following paragraphs substituted therefor:

11 (a) With respect to miscellaneous members, the city shall contribute the following percentages of monthly salaries earned as miscellaneous members of said System:

- (1) 3.555 percent until June 30, 1984 on account of the liability for prior service benefits.
- (2) 5.783 percent on account of the liability for current service benefits.

11 (b) With respect to local safety members, the city shall contribute the following percentages of monthly salaries earned as local safety members of said System:

- (1) 6.743 percent until June 30, 1984 on account of the liability for prior service benefits.
- (2) 9.994 percent on account of the liability for current service benefits.

C. This amendment shall be attached to said Contract and shall become effective on the First day of December, 1968
