ORDINANCE NO. 607

AN ORDINANCE AMENDING SECTIONS 6-1.21. AND 6-1.39.  
OF THE SAN ANSELMO MUNICIPAL CODE BY INCREASING  
THE RATE OF GROSS RECEIPTS BUSINESS LICENSE TAXES.

The City Council of the City of San Anselmo do ordain as follows:

Section 1. Section 2-121. (Title 6, Chapter 1) of the San Anselmo Municipal Code is hereby amended by changing the business license tax table to read as follows:

Section 2. Section 6-1.39. is hereby amended by changing the last sentence of (a) to read as follows:

In addition, he shall pay a gross receipts license tax at the time of taking out each permit in the Building Department at the rate of fifty (50¢) cents per thousand dollars (or part thereof) computed on the amount for which the permit is issued.

Section 3. This ordinance shall take effect immediately upon its passage and adoption because it relates to taxes for the usual and current expenses of the City, provided, however, that the imposition of the tax shall not take effect until January 1, 1971.

Section 4. This ordinance shall be published once in full, within fifteen (15) days of its final passage and adoption in The Reporter, a newspaper published and of general circulation in the City of San Anselmo.

The foregoing ordinance was introduced at a regular meeting of the San Anselmo City Council held on November 24, 1970, and was thereafter at a regular meeting of the City Council held on December 8, 1970, duly passed and adopted by the following vote:


