ORDINANCE NO. 698

AN ORDINANCE AMENDING CHAPTER 3 OF TITLE 5 RELATING
TO GARBAGE DISPOSAL

The Town Council of the Town of San Anselmo does ordain as follows:

1. Section 5-3.01 is amended to delete subsections (d), (e), (f) and the final un-lettered paragraph.

2. Section 5-3.03 is amended so that the last sentence of said section shall read:

"Each filled container shall not exceed a total of seventy-five (75) pounds in weight including the weight of the container."

3. Section 5-3.05 is hereby repealed. A new Section 5-3.05 is enacted to read as follows:

Section 5-3.05. Rates for Collection and Collection Services.

(a) A comprehensive rate schedule for the collection of garbage and dry waste shall be established by the Council from time to time, after public hearing.

(b) Residential Rates. The rate schedule shall provide a monthly rate for weekly pick-up of each thirty-two (32) gallon can or equivalent from a residence, may provide differential rates for users selecting recycling service and/or multiple can service, shall provide one-time charges for extra pick-up at time of regular service or at other times, and for occasional debris box rental. The residential rate schedule shall apply to each unit in a multiple residential building, provided that recycling rates shall be applicable only if the building owner and all tenants commit in writing to participate in a recycling program established pursuant to Section 5-3.02(c) of this Chapter.

(c) Commercial rates. Commercial rates may be negotiated between the user and the official garbage collector, provided the minimum monthly charge is no less than the minimum residential rate for one (1) can non-recycle, and the maximum charge per pick-up or for debris box rental does not exceed ceilings established by the Council in the comprehensive rate schedule.


(d) Selection of Service.

- (1) New residential users shall be informed of the types of service available and shall make their choice of service prior to the commencement thereof. If no choice is made, the official garbage collector shall provide and bill for single can non-recyclable service.
- (2) Continuing residential users may, by written notice to the official garbage collector at least thirty (30) days in advance, change from one type of service to another available type as of the first day of any calendar quarter.
- (3) Annually, between the first and twentieth days of November, the official garbage collector shall send each residential user, in a form approved by the chief administrative officer, an explanation of any recycling program established pursuant to Section 5-3.02(c) of this Chapter, a calendar of recycling pick-ups for the following year, and a statement of the availability of a five (5%) per cent discount for annual payment in advance per Section 5-3.06 of this Chapter.

4. Section 5-3.06 is amended to correct the heading by substituting a semi-colon for a colon; to change the first line of subsection (a) to read "The rates established pursuant to Section 5-3.05. . ."; to change 1.00 per month to 3.00 per month in the two places where 1.00 appears in subsection (b); and, to add to the end of the first sentence of subsection (c) the following:


". . . to each family or business entity located on the property."
