13 CONSOLIDATED PRECINCT "B" comprising State and County Precincts
14 Nos. 218, 219, 232, 243, and the polling place thereof shall
15 be the City Hall, San Anselmo Avenue.

16 CONSOLIDATED PRECINCTS "C" comprising State and County Precincts
17 No. 233, 242, and the polling place thereof shall be Myers
18 Roofing Service Co.

19 CONSOLIDATED PRECINCT "D" comprising State and County Precincts
20 216, 226, 234, 240, and the polling place thereof shall
21 be the Isabel Cook School, Sir Francis Drake Blvd.

22 CONSOLIDATED PRECINCTS "E" comprising State and County Precincts
23 220, 223, 224, 227, 228, 238, and the polling place thereof shall
24 be Guglielmo Garage, 1401 San Anselmo Avenue.

25 CONSOLIDATED VOTING PRECINCT "F" comprising State and County
26 Precincts No. 221, 222, 225, 229, 235, 236, 237, 241, and the
27 polling place thereof shall be Dini's Garage, 125 Butterfield Road.

28 BE IT FURTHER RESOLVED THAT THE ELECTION OFFICERS for said
29 ELECTION shall receive as compensation for their services the sum
30 of \$10.00 each, and they shall be as follows:
