

RESOLUTION 731

RESOLVED by the City Council of the City of San Anselmo that a General Municipal Election will be held in the City of San Anselmo on Tuesday, the 8th day of April 1958 for the purpose of electing the following officers:

Three Councilmen for the full term of four years

BE IT FURTHER RESOLVED, there will be six voting precincts for the purpose of holding said election, which precincts shall be consolidations of the regular precincts for holding State and County elections, and shall be as follows:

CONSOLIDATED PRECINCT "A" comprising State and County Precincts Nos. 230, 231, 239, 245, 246, and the polling place thereof shall be Wade Thomas School, 115 Kensington Road. *935 Voters*

CONSOLIDATED PRECINCT "B" comprising State and County Precincts Nos. 232, 243, 244, and the polling place thereof shall be the City Hall, San Anselmo Avenue. *Voters 577*
