

RESOLVED by the City Council of the City of San Anselmo that a **Special** Municipal Election will be held in the City of San Anselmo on Tuesday, the 14th day of July 1959, for the purpose of voting on the following proposition:

Shall the following offices or positions be withdrawn from the classified Civil Service System under Ordinance No. 244:

Police Chief - Head of Police Department  
Fire Chief - Head of Fire Department  
Building Inspector - Head of Building Department  
Park & Playground Superintendent, Head of the Park & Recreation Dept.  
Superintendent of Streets, Head of the Street Department

BE IT FURTHER RESOLVED, there will be six voting precincts for the purpose of holding said election, which precincts shall be consolidations of the regular precincts for holding State and County elections, and shall be as follows:

CONSOLIDATED PRECINCT "A" comprising State and County Precincts 230, 231, 239, 245, 246, and the polling place thereof shall be Wade Thomas School, 115 Kensington Road.

CONSOLIDATED PRECINCT "B" comprising State and County Precincts Nos. 232, 243, 244, and the polling place thereof shall be the City Hall, San Anselmo Avenue.

CONSOLIDATED PRECINCT "C" comprising State and County Precincts Nos. 233, 242, 247, and the polling place thereof shall be State Farm Automobile Insurance Office, 201 Redhill Avenue.

CONSOLIDATED PRECINCT "D" comprising State and County Precincts Nos. 225, 226, 227, 234, 235, 240, and the polling place thereof shall be Isabel Cook School, 1000 Sir Francis Drake Boulevard.

CONSOLIDATED PRECINCT "E" comprising State and County Precincts Nos. 224, 228, 238, 248, 252, and the polling place thereof shall be Yolansdale School, 1385 San Anselmo Avenue.

CONSOLIDATED PRECINCT "F" comprising State and County Precincts Nos. 229, 236, 237, 241, 249, 250, 251, and the polling place thereof shall be Brookside School, Butterfield Road.

BE IT FURTHER RESOLVED THAT THE ELECTION OFFICERS for said Election shall receive as compensation for their services the sum of \$10.00 each and they shall be as follows:


