

RESOLUTION NO. 802

RESOLUTION DIRECTING LETTER OF HEALTH OFFICER
TO BE SPREAD UPON THE MINUTES

WHEREAS, the City Council of the City of San Anselmo, on March 10, 1959, passed its Resolution Finding That The Public Convenience and Necessity Require the Installation of Sanitary Sewers in Ash Avenue and Requesting Opinion of Health Officer, in Assessment District No. 1959-1 of the City of San Anselmo; and

WHEREAS, said resolution requested the Health Officer of the City of San Anselmo to investigate said proceedings to be undertaken and report his findings thereon to this City Council; and



Gentlemen:

Please be advised that I have examined the situation on Ash Avenue wherein the Council of San Anselmo proposes to undertake special assessment proceedings in Assessment District No. 1959-1 for paving.

It is the opinion of the undersigned that the installation of sanitary sewers in Ash Avenue where not already installed, is necessary as a health measure for the area involved, and it is my recommendation that the special assessment proceedings for construction of improvements on Ash Avenue shall be amended to include proceedings for the construction of sanitary sewers in that portion of Ash Avenue where sanitary sewers are not already installed.
