

RESOLUTION NO. 815

RESOLUTION ORDERING THE WORK

BE IT RESOLVED by the City Council of the City of San Anselmo, County of Marin, State of California, as follows:

1. The City Council of the City of San Anselmo, on the 15th day of July, 1959, adopted its Resolution of Intention No. 804 to order the therein described work and improvements to be done and made in Assessment District No. 1959-1, City of San Anselmo, County of Marin, State of California, which Resolution of Intention was duly and legally published in the time, form and manner as required by law, as shown by the affidavit of publication of said Resolution of Intention on file in the office of the City Clerk of said City of San Anselmo.

2. After the adoption thereof, notices of the passage of said Resolution of Intention, headed "Notice of Improvement", were duly and legally posted in the time, form, manner, locations and number as required by law, as appears from the affidavit of posting of said notices on file in the office of the City Clerk of said City of San Anselmo.

3. After the adoption thereof, copies of said Resolution of Intention were duly mailed to all persons owning real property proposed to be assessed for the improvements described in said Resolution of Intention No. 804, according to the names and addresses of such owners, as the same appear on the last equalized assessment roll for taxes prior to the day of such mailing, or as known to the City Clerk of the City of San Anselmo, which said copies were duly mailed in the time, form and manner as required by law.

4. The City Council has duly received and considered evidence oral and documentary concerning the jurisdictional facts in this proceeding and concerning the necessity for the contemplated work and improvements and the benefits to be derived therefrom and said City Council has now acquired jurisdiction to order the proposed improvement.

5. The public interest and convenience require the improvement herein referred to, and said City Council hereby orders that the work and improvements, as set forth and described in said Resolution of Intention No. 804, passed by the City Council on the 15th day of July, 1959, and as set forth in the plans and specifications heretofore adopted, be done and made.

6. The boundaries of the assessment district, and the grades to which said work and improvements are to be constructed, shall be those set forth and described in said Resolution of Intention No. 804, and in the plans and specifications therein referred to, reference to which is hereby made for all further particulars.

7. Sealed proposals or bids for the doing of said work and making of said improvements herein ordered shall be delivered to the City Clerk of the City of San Anselmo on or before 12:00 o'clock noon on the 16th day of September, 1959, at the office of said City Clerk in the City Hall, San Anselmo, California, which said time and place is hereby fixed as the time and place of a public meeting at which said bids will be publicly opened, examined and declared by the City Clerk of the City of San Anselmo. Said bids, after being publicly opened, examined and declared, will be calculated by the Engineer of Work of said Assessment District No. 1959-1, his report returned to the City Clerk, and the report of the results of the bidding and the calculations of the Engineer of Work will be reported to the City Council of the City of San Anselmo at the next regular meeting thereof. The City Council reserves the right to reject any and all proposals or bids should it deem this necessary for the public good, and also the bid of any bidder who has been delinquent or unfaithful in any former contract with the City of San Anselmo.
