

RESOLUTION NO. 823

RESOLUTION OF AWARD OF CONTRACT

WHEREAS, the City Clerk of the City of San Anselmo did on the 16th day of September, 1959, in open session, publicly open, examine and declare all sealed proposals or bids for doing the work and improvements described in Resolution of Intention No. 804 for the construction of certain improvements in Ash Avenue Assessment District No. 1959-1 of the City of San Anselmo, adopted on the 15th day of July, 1959, which Resolution is hereby expressly referred to for a description of said work and improvement and for all particulars relative to the proceedings under said Resolution of Intention; and

WHEREAS, said bids, after being publicly opened, examined and declared, were calculated by the Engineer of Work, his report returned to the City Clerk, and the report of the results of the bidding and the calculations of the Engineer of Work were reported to the City Council of the City of San Anselmo at its next regular adjourned meeting on September 16, 1959;

NOW, THEREFORE, IT IS HEREBY RESOLVED that the City Council of the City of San Anselmo, Marin County, California, hereby rejects all of said proposals or bids except that herein mentioned, and hereby awards the contract for doing said work and improvement to the lowest responsible bidder, to wit:

at the prices named in the bid of said bidder on file in the office of the City Clerk of the City of San Anselmo.

Said City Clerk of the City of San Anselmo is hereby directed to publish notice of said award in the ROSS VALLEY TIMES, a newspaper published and circulated in said City of San Anselmo, and and heretofore designated for that purpose by said City Council of the City of San Anselmo.
