BE IT FURTHER RESOLVED, there will be six voting precincts for the purpose of holding said election, which precincts shall be consolidates of the regular precincts for holding State and County elections, and shall be as follows:

CONSOLIDATED PRECINCT "A" comprising State and County Precincts Nos. 2230, 2231, 2239, 2245, 2246, and the polling place thereof shall be Wade Thomas School, 115 Kensington Road. Total registered voters 1154

CONSOLIDATED PRECINCT "B" comprising State and County Precincts Nos. 2232, 2243, 2244, and the polling place thereof shall be the City Hall, San Anselmo Avenue. Total registered voters 655

CONSOLIDATED PRECINCT "C" comprising State and County precincts Nos. 2233, 2242, 2247, and the polling place thereof shall be Palmquist-Nilsen Linoleum Company, 216 Greenfield Avenue. Total register voters 674
