

RESOLUTION NO. 1101

RESOLUTION DECLARING THE CANVASS OF RETURNS AND RESULTS OF GENERAL MUNICIPAL ELECTION HELD ON APRIL 12th 1966.

WHEREAS, a General Municipal Election was held on the 12th day of April 1966, as required by law, and

WHEREAS, it appears that notice of said election was duly and legally given as required by law, and voting precincts were properly established; that election officials were duly appointed and served and election supplies furnished and that in all respects said election was held and conducted and the votes thereat received and canvassed and the returns thereof made and declared in the time, form, and manner required by the Election Code of the State of California governing elections in General Law Cities, and

WHEREAS, the City Council of the City of San Anselmo met at the council chambers in said City of San Anselmo on Tuesday, the 19th day of April 1966, to canvass the returns of said election and to install the newly elected officers and as a result of which, the City Council finds that the number of votes, the names of the persons voted for, and other matters required by law, to be as hereinafter stated,

NOW THEREFORE, BE IT RESOLVED as follows: That the said General Municipal Election was held and conducted in the City of San Anselmo on Tuesday, the 12th day of April 1966, in the time, form and manner as required by law, that there were seven voting precincts established for the purpose of hold said election, consisting of a consolidation of the regular election precincts for holding State and County elections, as follows to-wit:

CONSOLIDATED VOTING PRECINCTS #1, comprising State and County Precincts Nos. 2208, 2209, 2210, 2211, 2212, and the polling place thereof shall be Wade Thomas School.

CONSOLIDATED VOTING PRECINCTS #2, comprising State and County Precincts Nos. 2207, 2213, 2214, 2215, and the polling place thereof shall be City Hall.

CONSOLIDATED VOTING PRECINCTS #3, comprising State and County Precincts Nos. 2202, 2203, 2204, 2205, 2206, and the polling place thereof shall be Aquilino Garage, #5 Jordan Avenue.

CONSOLIDATED VOTING PRECINCTS #4, comprising State and County Precincts Nos. 2200, 2201, 2220, 2225, 2226, 2227, and the polling place thereof shall be Isabel Cook School.

CONSOLIDATED VOTING PRECINCTS #5, comprising State and County Precincts Nos. 2216, 2217, 2218, 2219, 2221, 2222, and the polling place thereof shall be Turrini's Garage, 85 Elm Avenue.

CONSOLIDATED VOTING PRECINCTS #6, comprising State and County Precincts Nos. 2223, 2224, 2228, 2229, 2231, 2232, and the polling place thereof shall be Brookside School.

CONSOLIDATED VOTING PRECINCTS #7, comprising State and County Precincts Nos. 2230, 2233, 2234, 2235, 2236, and the polling place thereof shall be San Anselmo Fire Station #2.
