BE IT FURTHER RESOLVED, there will be seven voting precincts for the purpose of holding said election, which precincts shall be consolidates of the regular precincts for holding State and County elections, and shall be as follows:

CONSOLIDATED PRECINCT 2005 comprising State and County Precincts Nos. 2200, 2203, and the polling place thereof shall be Aquilino Garage, 5 Jordan Avenue. 614

CONSOLIDATED PRECINCT 2006 comprising State and County Precincts Nos. 2202, 2204, 2205, and the polling place thereof shall be the City Hall, San Anselmo Avenue. 1179

CONSOLIDATED PRECINCT 2007 comprising State and County Precincts 2201, and the polling place thereof shall be Wade Thomas School, 115 Kensington Road. 439

CONSOLIDATED PRECINCT 2008 comprising State and County Precincts 2206, 2207, 2208, and the polling place thereof shall be Yolansdale School, 35 Elm Avenue. 1120

CONSOLIDATED PRECINCT 2009 comprising State and County Precincts 2209, 2212, 2213, and the polling place thereof shall be Brookside School, 116 Butterfield Road. 1251

CONSOLIDATED PRECINCT 2010 comprising State and County Precincts 2210, 2211, and the polling place thereof shall be San Anselmo Fire Station #2, 150 Butterfield Road. 671


