CITY OF SAN ANSELMO RESOLUTION NO.1320

A RESOLUTION RESTRICTING THE PARKING OF VEHICLES IN AND UPON ALL CITY OWNED PUBLIC PARKING LOTS AND SETTING PARKING LICENSE FEES.

GOOD CAUSE APPEARING THEREFOR, IT IS HEREBY RESOLVED by the City Council of the City of San Anselmo as follows:

- 1. Upon this resolution going into full force and effect, resolutions numbered 1232 and 1313 heretofore passed by the City Council are rescinded and revoked by this resolution.
- 2. As provided for hereinafter, the CREEKSIDE PARKING LOT, as more particularly depicted and delineated on the attached plot plan marked Exhibit "A" and located on the southwest corner of Center Boulevard and Sir Francis Drake Boulevard, shall have the following restrictions applicable to it:
 - (a) "Restricted Area" as delineated on Exhibit "A".

 Parking within said "restricted area" from six (6) o'clock

 a.m. to six (6) p.m. will be restricted to holders of currently valid

 parking permits excepting Saturdays, Sundays and Holidays, when no

 parking license permits will be required for parking thereon.
 - (b) "Nonrestricted" public parking portion of Exhibit "A"

 Parking with said "nonrestricted area" from six (6) o'clock

 a.m. to six (6) o'clock p.m. no valid parking license permit shall be required except that there shall be a four (4) hour parking limit. On Sundays and Holidays there shall be no time limitation on the public parking between these hours.
- 3. Parking of authorized motor vehicles in the public parking lot at Forest and Lansdale Avenues, at any time of the day or night, any day of the week, including Sundays and Holidays, is limited to holders of currently valid parking license permits.

- 4. (a) Parking in the PINE STREET PARKING LOT and MAGNOLIA PARKING LOT in the City of San Anselmo between the hours of midnight and six (6) o'clock a.m. on any day of the week including Sundays and Holidays is limited to holders of currently valid parking license permits.
- (b) Parking in the PINE STREET PARKING LOT and MAGNOLIA

 PARKING LOT in the City of San Anselmo between the hours of six (6)

 o'clock a.m. to six (6) o'clock p.m. shall not require a valid parking permit

 and shall be limited to four (4) hours on all days except Sundays and

 Holidays. On Sundays and Holidays there shall be no time limitation on

 the public parking between these hours.
- 5. The charge for a parking license permit fee is hereby established to be the sum of FIVE (\$5.00) DOLLARS per month per vehicle. Parking permits issued after the fifteenth (15th) day of any month shall be at one-half (1/2) the whole monthly rate, and such permits shall be valid for the remainder of that calendar month. Parking permits are valid in any of the public parking areas where permits are required.
- 6. From and after the effective date of this Resolution, the parking of vehicles in and upon publicly owned parking lots shall be restricted to the following vehicles and the parking thereon of any other vehicle is prohibited and hereby made unlawful.
 - (a) Passenger automobiles or motorcycles where bear no sign or other indicia that the same is offered for sale. Passenger automobiles or motorcycles bearing "For Sale" signs or other indicia of sale are prohibited.
 - (b) Trucks of a pick-up body type having a load capacity of not more than 3/4 of one ton, and which bear no sign or other indicia that the same is offered for sale. Trucks bearing "For Sale" signs or other indicia of sale are prohibited.

- 7. The City Clerk shall issue the parking lot license permits upon application therefor. Upon payment for the permit the licensee shall be issued a sticker or decal which shall be valid when displayed in an area of seven (7) square inches in the lower right-hand corner of the windshield. The stickers or decals shall be issued monthly, and the currect sticker or decal shall be displayed as aforesaid.
- 8. The Chief of Police is hereby directed to procure, install and maintain appropriate and clearly visible signs designating the restrictions contained in this resolution. This resolution shall be in full force and effect when the said signs have been posted, and thereafter it shall be unlawful for any person, firm, corporation or association to park any vehicle in violation of the restrictions herein.
- 9. This resolution is passed pursuant to the authority of Section 3-4.06 of the San Anselmo Municipal Code.
- 10. It shall be unlawful for any unlicensed vehicle to park in any restricted parking area.
