

CITY OF SAN ANSELMO

RESOLUTION # 1365

A RESOLUTION OF INTENTION OF THE CITY COUNCIL OF THE CITY OF SAN ANSELMO PURSUANT TO SECTION 35270 OF THE GOVERNMENT CODE OF THE STATE OF CALIFORNIA TO TRANSFER CITY TERRITORY NOW IN THE CITY OF SAN ANSELMO TO THE CITY OF ROSS.

WHEREAS, there is presently located as part of the City of San Anselmo five subdivided lots which portion is approximately 2.96 acres more or less, and a subdivision was recently approved for this property which is partly in the Town of Ross, partly in the City of San Anselmo and partly in the City of San Rafael, and

WHEREAS, this property would be better served by the Town of Ross than by the City of San Anselmo since the only public access is by Baywood Lane in Ross. The said property itself is located on Crest Road which, at that point, is in the Town of Ross, and

WHEREAS, there has recently been constructed on said property a new home having a very high market and assessed valuation and which home is located entirely within the Town of Ross, and

WHEREAS, Crest Road is an unaccepted road and is not maintained by the City of San Anselmo and the only legal access to said property is through the Town of Ross, and

WHEREAS, the portion of said property in the City of San Anselmo is assessed at \$1,350.00 representing taxes in the amount of \$30.38, and

WHEREAS, there is attached hereto a portion of the assessor's map showing the said 2.96 acres outlined in red and which is known as assessor's parcel 6-221-12, and


WHEREAS, the owner of said parcel is desirous to transfer said property to the Town of Ross so that the entire contiguous ownership will be under one city jurisdiction, and

WHEREAS, it appears that the Town of Ross is willing to accept annexation of said parcel.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

That the property generally known as Assessor's Parcel 6-221-12 consisting of 2.96 acres be transferred from the City of San Anselmo to the Town of Ross, a contiguous city, pursuant to Section 35270 et. seq. of the Government Code of the State of California.

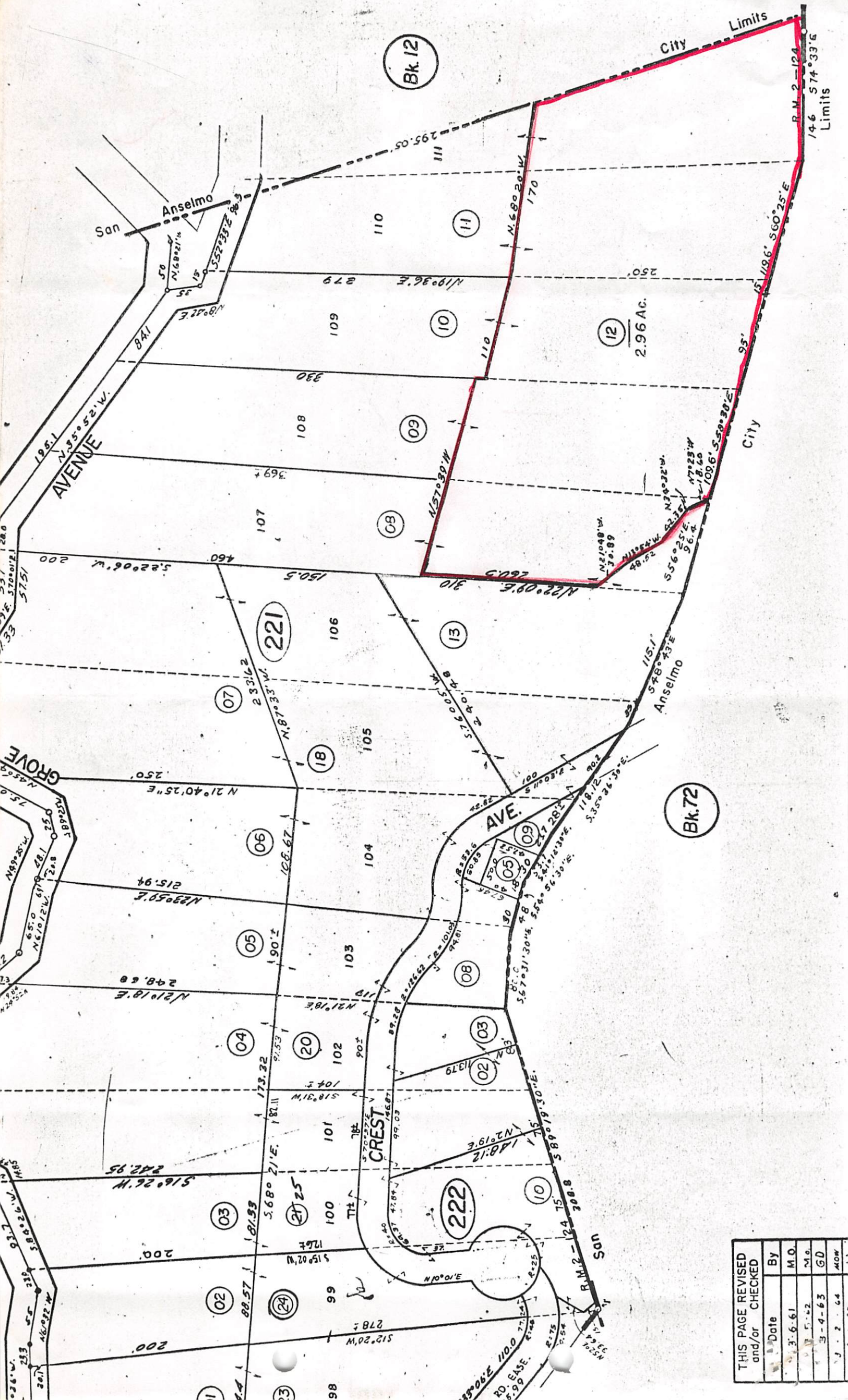
