

this resolution.



AGREEMENT TO PURCHASE TAX-DEEDED LAND

THIS AGREEMENT, made on the 10th day of October, 1972, by and between the Board of Supervisors of the County of Marin, and the County of Marin, hereinafter jointly called "Board," and the City of San Anselmo, a municipal corporation, hereinafter called "City," pursuant to the provisions of Division 1, Part 6, Chapter 8, of the Revenue and Taxation Code.

W I T N E S S E T H:

WHEREAS, the several parcels of real property situated within the City of San Anselmo, County of Marin, State of California, hereinafter set forth in Exhibit "A," attached to and made a part hereof, have been deeded to the State of California, for the non-payment of delinquent taxes; and

WHEREAS, such deeds to the State for taxes include taxes levied by City, which taxes on the property are collected by the County officers:

NOW, THEREFORE, it is mutually agreed as follows:

1. That as provided by Section 3800 of the Revenue and Taxation Code, the cost of giving notice of this agreement shall be paid by City.


2. That Board agrees to sell to said City and said City agrees to purchase from said Board the parcels of property hereinafter set out in Exhibit "A," attached hereto and made a part hereof, which shall not have been redeemed as provided in the Revenue and Taxation Code, upon payment by said City to the Tax Collector of said County the sum set forth in said exhibit after the description of the property and designated "Purchase Price," within ten (10) days after this agreement

becomes effective.

3. That City will not share in the distribution of the payment required by this agreement.

IN WITNESS WHEREOF, the parties hereto have caused their respective names to be hereunto subscribed and their respective seals to be hereto affixed.
