RESOLUTION NO. 1647

RESOLUTION DECLARING THE CANVASS OF RETURNS AND RESULTS  
OF GENERAL MUNICIPAL ELECTION HELD ON MARCH 2, 1976

WHEREAS, a General Municipal Election was held on the 2nd day of March, 1976, as required by law, and

WHEREAS, it appears that notice of said election was duly and legally given as required by law, and voting precincts were properly established; that election officials were duly appointed and served and election supplies furnished and that in all respects said election was held and conducted and the votes thereat received and canvassed and the returns thereof made, and declared in the time, form, and manner required by the Election Code of the State of California governing elections in General Law Cities, and

WHEREAS, the Town Council of the Town of San Anselmo met at the Council chambers in said Town on Tuesday, the 9th day of March, 1976, to canvass the returns of said election and to install the newly elected officers and as a result of said election the Town Council finds that the number of votes, the names of persons voted for, and other matters required by law, to be as hereinafter stated,

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS: That the said General Municipal Election was held and conducted in the Town of San Anselmo on Tuesday, the 2nd day of March, 1976, in the time, form, and manner as required by law, there were nine voting precincts established for the purpose of holding said election, consisting of a consolidation of the regular election precincts for holding State and County elections, as follows, to-wit:

CONSOLIDATED PRECINCT NO. 2006 comprising State and County Precincts Nos. 2200 and 2203 and the polling place was the Krahl Residence, 60 Sequoia.

CONSOLIDATED PRECINCT NO. 2007 comprising State and County Precinct No. 2201 and the polling place was the San Anselmo Presbyterian Church, 72 Kensington Rd.

CONSOLIDATED PRECINCT NO. 2008 comprising State and County Precincts Nos. 2202 and 2204 and the polling place was Ongaro Plumbing, 243 San Anselmo Avenue.

CONSOLIDATED PRECINCT NO. 2009 comprising State and County Precincts Nos. 2205, 2214 and 2215 and the polling place was Isabel Cook School, 1000 Sir Francis Drake Blvd.

CONSOLIDATED PRECINCT NO. 2010 comprising State and County precincts Nos. 2206 and 2207 and the polling place was the Raudio Residence, 50 Florence Ave.

CONSOLIDATED PRECINCT NO. 2011 comprising State and County precincts Nos. 2208 and 2209 and the polling place was the Church of the Nazarene, 1509 Sir Francis Drake Blvd.

CONSOLIDATED PRECINCT NO. 2012 comprising State and County precincts Nos. 2210 and 2211 and the polling place was San Anselmo Fire Station #2, Arroyo & Butterfield Roads.

CONSOLIDATED PRECINCT NO. 2013 comprising State and County precincts Nos. 2212 and 2213 and the polling place was the Nilsen Residence, 32 Meadowcroft Dr.

CONSOLIDATED PRECINCT NO. 2014 comprising State and County precincts Nos. 2216 and 2217 and the polling place was the Farey Residence, 126 Madrone Ave.
