

1 WHEREAS, heretofore on the 6th day of March 1950, Ruliford H. Tee-
2 ter filed a verified petition, pursuant to Ordinance # 254, for
3 the rezoning of that certain real property situate in the Town of
4 San Anselmo, County of Marin, State of California, described as
follows, to wit:

5 Lots 30 & 31 Block 2 Sunnyside Tract
6 from First Residential District Property to Commercial District
7 property as said districts are delineated and shown in Ordinance
8 No. 254 of the Town of San Anselmo, and

9 WHEREAS, said City Planning Commission has considered said veri-
10 fied petition, and said Planning Commission has made its Tentative
11 Report thereof, and

12 WHEREAS, the City Council of the Town of San Anselmo and the City
13 Planning Commission of the Town of San Anselmo thereafter fixed
14 the 27th day of March 1950 and the 3rd day of April 1950, as dates
15 for public hearings on said Tentative Report, and

16 WHEREAS, the Planning Commission gave due notice of said meetings
17 as required by law and the order of the City Council, and held
18 said public hearings at the times and places specified, affording
19 all interested persons an opportunity to be heard, and

20 WHEREAS, on the 5th day of April 1950, the City Planning Commission
21 filed its final report with the City Council of the Town of San
22 Anselmo, and

23 WHEREAS, the City Council of the Town of San Anselmo, on the 5th
24 day of 1950 received said final report, and it appearing that
25 the City Council should hold a public hearing on said final report
26 and said verified petition as required by law,

27 NOW, THEREFOR, BE IT RESOLVED by the City Council of the Town of
28 San Anselmo as follows:

29 1.-That the 18th day of April 1950, at the Council Chambers, in
30 the City Hall in the Town of San Anselmo, County of Marin, State

2.-That the City Clerk of the Town of San Anselmo be, and he is hereby authorized and directed to give notice as follows:

(a) By posting, at least seven days prior to the above date set for hearing, copies of the attached form of notice in three public places in the Town of San Anselmo, hereby fixed as follows:

- (1) Bulletin Board, San Anselmo Public Library
- (2) Bulletin Board, San Anselmo Post Office
- (3) Bulletin Board, San Anselmo City Hall

(b) Publication of a copy of the attached notice in the San Rafael Independent* Journal, a newspaper of general circulation in the Town of San Anselmo in at least three separate issues within the week preceding the date of said hearing.
